PROCESS DESCRIPTION

Organic Blue Agave Complex Syrup is a sweet syrup containing fructose, dextrose, and inulin. It is obtained by extracting, purifying, and hydrolyzing the naturally occurring carbohydrates found in the Blue Agave plant. The hydrolysis is stopped before breaking the naturally occurring inulin completely into sugar, so the syrup contains pre-biotic soluble fiber.
